FOREWARD

Developing a history of the West Point Golf Club has not been without its difficulties.

Unfortunately memories have dimmed, older members have gone, written records and pictures have been lost, destroyed or never published.

It is doubtful that a complete account of the Club or its members will ever be fully documented.

This compilation of events from 1932 through 1990 has been reconstructed from the limited information that is available. Achievements of early members is sparse or non-existant, and it must be assumed that the success of the Club was due to the outstanding interest, ability and accomplishments of these pioneer members.

I would like to give special credit to a long time Ladies' Club Member, Elsie Irwin, for her research in 1975, on the early development of the University Golf Course. Also to Roli Parker for editing much of the early history.

The material from 1985 through 1990 has been developed more in the form of a chronology rather than a history. The writer felt that a single record of major yearly events would lend itself to much easier access for information in the years to come.

Although such a compilation of events may seem tedious to some, there will always be that day in the future when such information may be needed.

It is hoped that a written record of the Club, its members and special achievements will be continued and amplified in future years.

WEST POINT GOLF CLUB

1932 - 1990

The West Point Golf Club was organized in 1932 by a group of avid golfers, who played regularly at the newly completed University Golf Course. The principles behind the formation of the Club are the same today as they were in 1932; to provide the opportunity,

- To foster the Game of Golf.
- To provide good fellowship and camaraderie.
- To participate in Club competitions and social activities.
- To obtain an official handicap thereby enabling play on an equitable basis.
- To support the British Columbia and Royal Canadian Golf Associations.


The University Golf Course had a checkered beginning. In 1923 the Provincial Government under Premier John Oliver set aside 2900 acres of land on Point Grey adjacent to the newly re-located University of British Columbia. This property, popularly called the University Endowment Lands, was intended to provide long term funding for the University. However, it has never been much of a factor in University financing. On November 16, 1928 an Order-in-Council was passed to establish a Public Golf Course on the University Endowment Lands on either side of University Boulevard.

Mr. J.M. Ballard obtained the original lease and signed an agreement to build and operate a Public Golf Course. The course was to cost a minimum of \$60,000 to establish and the lease was for twenty years. The government was to receive a fee of \$1,800 per year plus land taxes. The agreement specifically noted that the Golf Course must be public and that all fees were to be approved by the Minister of Lands. The proposed construction of the Golf Course was a popular move, particularly with the University population and the residents of the west side of Vancouver.

The course was under construction from 1928 to 1930. The principal contractor was the General Construction Company; Mr. John Boyd, President and Mr. J. McPherson, design engineer. Mr. David (Davey) Black, professional at the Shaughnessy Golf Club, was the architect.

The Clubhouse was built by Mr. Frank Mountain. Mr. Harry Winder, professional at Riverside, California and a brother-in-law of Davey Black, came from California to take the position of professional on May 15, 1930. The Course opened a little over a week later, on May 24, 1930, with an uncompleted Clubhouse and only 9 holes ready for play. The opening ceremony was well attended by local residents and eager golfers, who had waited for more than two years for the event. The ceremony was held in front of the "Shack" which became Harry Winder's Pro Shop for many years.


Golfers toting their wooden shafted clubs in their "drain pipe" bags became a common sight riding the Point Grey street cars grinding up the 10th Avenue hill to Sasamat. The small "English" ball was the official golf ball in Canada. Only Americans used the "big" ball. Clubs were still known by name rather than number, and woods were woods. Part of the equipment found on every tee was a bucket of sand and a bucket of water for dampening the sand to fashion ball tees.

A year after opening, Mr. Ballard signed the lease for the Course over to Mr. John Boyd, who became President of the Westward Ho Golf Course Ltd. The 1930's were pleasant years for everyone associated with the course. Under the direction of Harry Winder, who enjoyed excellent rapport with Mr. Boyd and popularity with the golfers, everything went smoothly making it a very enjoyable place to play golf. The course was well run and kept in excellent condition with grass tees and well watered fairways.

In 1931 Mr. Boyd presented the University Cup for an annual competition among the regular players on the golf course.

Mr. Norm Wilkinson was the first winner of the University Cup, which was played as a Match Play Event. With the impetus of this competition, it was inevitable that the growing group of regular players would get together to form a Club to participate in organized competitions and social activities.

In 1932, with the help of Harry Winder, the West Point Golf Club was formed. The founding members elected Mr. J.H. Lucas their first President. Among this group was Norm Wilkinson, who became the Club's sixth President. Initially the membership was limited to 100, but was later increased to 150 due to popular demand. The original Competition Day was Sunday. As the membership increased, Saturday also became a Competition Day. The competition finals, Saturday winners versus Sunday winners, were traditionally held on Sunday. The initial membership dues were \$10.00. Green fees were fifty cents a round with a second round thirty-five cents and a twilight round twenty-five cents.



As the years passed, the Club acquired a number of beautiful Trophies and Shields, which were donated by long time members;

The Bret Meating for Senior 54 Hole Medal Play.

The Brodie Shield for 2 Ball-Best Ball.

The Wolridge Shield for 4 Ball-1st & 2nd Ball

The Qantas Shield for Singles Match Play (0-13 hdcp)

The Gilmour Shield for Singles Match Play (14-18 hdcp).

The Golfcraft Shield for Singles Match Play (19-up hdcp).

The Ruebe Haack Shield for Monthly Medal Playoff.

The Centennial Cup for Low Net.

The Stew Smith Shield for the Most Improved Player.

Each Trophy and Shield holds many happy memories for every member of stiff competitions, wonderful fellowship and thoughtful appreciation of those, who graciously donated these perpetual awards to the Club.

Members will recall the names of many of the Club's outstanding golfers, who competed in the Club's competitions over the years. Some are still members of the Club today. Some of the players, who may come readily to mind are; Ken Murray, Jerry Shook, Dick Stewart, Charlie Robertson, Johnnie Johnston, Pete Hanton, Sandy Taylor, Dick Cattermole, Chuck Menzies, Jim Simpson, Bret Meating, Jack Derbyshire, Ralph Pasmore, Norm Wilkinson, Doug Symonds, Mel Jacobs, Jack Woolner, Dick Hanley, Joe Dwyer and Bill Watkins who was the 3 time winner of the Club Singles Championship.

A complete book could be written about the hundreds of incidents, some causing momentary grief others smiles of lasting jubilation, that occurred during the many hard played competitions over the years. Unfortunately memories have dimmed, older members have gone, and written records have been lost or destroyed, so a full picture of our golfing greats can not be told.

Perhaps the mention of a few unusual exploits may prick the memories of some members to recall many other interesting stories.

"The most unusual 3 stroke Hole-in-One occurred a few years back. Norm Clark, playing with Andy Main and others, stroked his first shot out of bounds on the par 3, 15th hole. He teed up a second ball and lofted it straight into the hole. A Hole-in-One in 3 strokes."

"Playing for the Harry Winder Trophy, Roy Moulton was 8 strokes up with 18 holes to play, then the roof fell in. Peter Roche with superb play pulled into a tie with Roy at a 202 net score. Tim Oke, on the verge of passing both Roy and Peter, put 2 balls out of bounds for a disastrous 9 strokes and a 203 net. Roy weathered the storm by beating Peter in an 18 hole playoff."

"Extraordinary to say the least was the amazing shot making of long time member, Jim Simpson, during the week of October 1, 1979. On Monday, playing with Jerry Smyth, Norm Raphael, and Ed Angel, Jim teed up his ball on the par 3 ninth hole and stroked it for an easy Hole-in-One. On Friday, again playing with Mid-Weekers, Jim teed up his ball on the par 3 fifteenth hole stroked into the hole for a second Hole-in-One."

"For terrific shot making - Ken Murray playing in a downpour on May 2, 1976, shot an unbelievable gross 67. Under better playing conditions, Ken established a course record gross 63. Some may remember Ken and his 4 to 5 inch tees."

"On August 7, 1979, Andy Girling, son of member John Girling, playing with two West Point Golf Club members, shot a gross 63 to tie Ken Murray's course record."

The annual "Monkey Golf and Smoker" was a prominent fixture on the activity schedule from the 1940's thru the 1970's. This was a team competition. The captain of each team allotted one club to each player on the team. Teams played in unbroken sequence regardless of where the ball rested, with the player whose turn it was to play utilizing whatever club he was allotted, a driver, putter, 5 iron, or 9 iron. Low gross score decided the winner. The game required "serious" concentration, but roars of laughter could always be heard over Point Grey on the evenings it was played.

Another popular and well attended social and "golf" event was the annual "Putting Contest and Smoker". This was a team event as well as an individual contest. Rather than a simple putting event, the putting green was set up with well designed obstacles to test the ingenuity of every participant. Some extra-ordinary results were produced with complete consternation exhibited by the Club's best golfers. The evening finished off with a distribution of prizes and refreshments.

The Palcutta Smoker and Tournament was organized in 1973 to replace Monkey Golf which was dropped due to a lack of free evening golf course time being granted by the "new" course administration. This event attracted the interest of all members and soon became the Club's major event in the fall.

All of these events were great get-to-gether activities, and created many pleasant hours of fellowship and fun.

From the earliest days, the Club members were interested in the training and encouragement of Junior golfers. Laurie Roland, a very outstanding Junior, who achieved many victories before his untimely death in an airplane accident, was our Club Junior Champion in 1945. In the 1960's under the guidance of Norm Johnson, Ken Child, Len Marchand and others the Junior Program reached a high point with clinics, driving range practice and tournament competitions.

Also, selected players were sent to the Junior Golf College, a summer golf camp that had been established in Chilliwack, for added training.

In the 1970's Wally Gourlay and Bill Watkins carried on the work of the Junior Development Program, and developed some excellent Junior Golfers despite the difficulty of working on a Public Golf Course without reciprocal playing privileges with other clubs. At an Annual Meeting, Bill Watkins said in response to the question, Is the Junior Development Program worthwhile?

"When a young boy or girl is given the opportunity to learn the basics of golf, they receive much more than golf lessons, instruction in etiquette and rules. They learn such things as self discipline, how to get along with others, reward for effort, self control and much more. In my opinion any contribution in this direction, no matter how small, will always be worthwhile."

Membership declined between 1939 and 1945 as many of the members "went to war". With this drop in membership the Club had a few lean years. On one or two occasions a special levy was needed to keep the Club solvent. At one time, it became necessary to obtain a small loan. Thanks to Club President, Reube Haack, who was also a local bank manager, the Club had little difficulty in obtaining the money.

It wasn't long after the war ended that members, eager to participate in a game of golf, began to return. Membership increased and the Club never looked back.



1957 1932 PAST PRESIDENTS

In 1960 Mrs. Lillian Baldwin, daughter of John Boyd, became President of the Westward Ho Golf Course Ltd. She continued to operate the course until 1971 when major changes occurred in the course, its management, its professional and staff, and the fabric of the West Point Golf Club. The lease to the Westward Ho Golf Course Ltd. was not renewed by the Provincial Government and the management of the course was officially taken over by the University Endowment Lands on July 1, 1971.

Long time professional, Harry Winder, took this opportunity to retire after 41 years of outstanding service to the golfers on the University Golf Course. In his honor the West Point Golf Club added the Harry Winder Trophy in 1972, and planted a beautiful Corsican Pine on the knoll to the right of the first fairway around the 200 yard mark, as a living remembrance of his long servic to the Club.

The next few years were frustrating for the West Point Golf Club members and other regular players on the course. Grandiose plans were made to renovate and update the course. Mr. Bob Murdoch, Endowment Lands Manager, commented, "We plan to make many changes, to restore the course to what it once was, and to build a new clubhouse." Unfortunately the plans were ill advised, underfunded and seemed to lack an overall plan of action. There was a year with only 9 holes, ploughed fairways and long walks between tees. The course was only partially renovated and no beginning was made on a new clubhouse.

Mr. Ron Willey was appointed the new professional. He with Mr. Murdoch proposed some difficult administrative changes; pre-booking was eliminated, booked tee times were modified and decreased, free time on the course for special events was eliminated, and the Club was instructed to open membership to all comers. This last edict resulted in 62 additional members being accepted into the Club without any additional tee times. At the start of 1973, the Club had 252 members with tee times for less than one half that number.

In spite of these difficulties the Club continued to function. In fact the Club expanded in a new direction. It became apparent that a group of week day players wished to form a "Mid-Week" Club due to the inability of the existing week end Club to accommodate more players.

A preliminary investigation to determine the feasibility of this development was undertaken by Ed Angel in July of 1973. This included discussions with the University Endowment Lands administration, the course Professional and the potential week day players.

The study indicated that 20 or more week day players were definitely interested in a club that would enable them to enjoy full camaraderie and fellowship, to join in social events and activities, and to participate in golf competitions and tournaments. The Endowment Lands Administration and the course Professional indicated qualified approval.

A discussion was opened with the Executive by a letter to Don Close, Club President on March 32, 1974. This communication resulted in a fact finding meeting between the Club representative, Roli Parker, and the Mid-Week organizer, Ed Angel. This meeting established a set of guidelines for the formation of a Mid-week Club.

It was agreed that the Mid-Week Club would be a division of the West Point Golf Club. Membership would be limited to senior players 55 years and over. Membership would be capped at 25 for the first year. Final approval of Mid-Week membership applications would be made by the parent Club. Annual dues would be the same as the parent Club. The Mid-Week Club would have representation on the parent Club's Executive. Handicaps would be handled through the Club computer system. Members would receive Club, B.C.G.A and R.C.G.A. membership cards. Mid-Week members would compete in regular Mid-Week Competitions, only.

At a regular meeting of the Club's Executive on May 7, 1974 the formation of the Mid-Week Club was authorized. An announcement and distribution of Applications for Membership resulted in an initial 8 transfers from the parent Club and 12 new members. These 20 members were established as Charter Members of the West Point (Mid-Week) Golf Club.

An Opening Day Competition and Luncheon was held on May 22, 1974. Ed Angel was elected Captain and representative to the parent Club. A full Competition Schedule for 1974 was drawn up and trophies quickly made their appearance; The Gus Leonidas, The George Milne, The Neil McIntyre, The Ed Angel, The Royal Bank and the Kelbert.

It was a good beginning for a welcome addition to the West Point Golf Club's activities on the University Golf Course.



With the development of the Mid-Week Club and the need to redefine the operating functions of the Executive and Committees, it became necessary to up-date the existing Club By-Laws. An initial draft was prepared by Ed Angel for presentation to the Executive for their input on October 10, 1975. Under the legal guidance of Jesse Cove, a final draft of the Constitution and By-Laws was prepared and presented to the membership for acceptance at a Special General Meeting.

An application was made to the Provincial Registrar of Companies for incorporation of the West Point Golf Club under the Societies Act. The new Constitution and By-Laws were accepted, registered and filed on December 15, 1975. The West Point Golf Club was now an incorporated society.


Some golf clubs on the lower mainland cooperated for a number of years on a receprocal arrangement, whereby Executive members could play a round of golf at no charge upon presentation of a courtesy card. In 1975, complimentary cards were exchanged between McCleery, Fraserview, Beach Grove, Glen Eagles, Seymour and Pitt Meadows Golf Clubs.

A Club Logo was selected through an open competition held in 1976. There were many entries, but the one selected is the one the Club is still using. A club Crest, using the new Logo, was produced and distributed free of charge to each member in 1977. A Bag Tag was made available to the members shortly after at a nominal charge.



The West Point Golf Club participated in a Pro-Executive Tournament between Clubs in the 1970's. In this event, 3 Club Executives and a Pro formed a team to play a one day Stroke Play Competition with other Club teams. In 1976, 9 West Point Golf Club Executives teamed with Pro's Harry Winder, Dunc Sutherland, and Bill Hodgins for the event played at the Capilano Golf Club.

Pictured is Harry Winder with partners Wally Gourlay, Chuck Menzies and Ed Angel playing at the Marine Drive Golf Club in the 1977 Pro-Executive tournament. This was one of the last events that Harry Winder participated in, as his health slowly deteriorated.



In late 1979 Harry Winder passed away. The Club had lost a great friend, indeed a personal friend to all its members. After his retirement he frequently appeared at the clubhouse for a "cuppa" and to talk of old times. He was still "our Pro" until the day he died. Many will remember Harry in his 71st year in 1975 shooting a terrific 72 gross score. In his memory a Corsican Pine was planted on the right side of the first fairway on the knoll near the 200 yard mark. A short dedication ceremony was attended by Harry's family and many Club members on a sunny spring afternoon in 1980.

In the 1970's the Golf Course and Golf Club moved through a period of uncertainty, which increased each passing year. The Golf Course renovation program was stagnated. Rumors of a new clubhouse were merely figments of imagination. The management system adopted by the Endowment Lands Administration lacked foresight, training and authority. The administration of the Golf Course retrogressed to the point of merely collecting green fees.

In 1984 the Provincial Government called for proposals to lease the University Golf Course for a period of 20 years. Their primary interest was to place the golf course operation in private hands and to increase the revenue to the Crown. The proposals were to include the construction of a new clubhouse and completion of the renovation and up-grading of the golf course. A new lease was concluded and an official notification was made, that foretold the early demise of the West Point Golf Club on the University Golf Course.

"Effective April 1, 1985 the golf course shall become known as "The University Golf and Country Club."

Although the new lessee made few changes in the course operation in 1985, there was ample room for member concern about the Club's future on the course. There were immediate questions about the inordinate increase in green fees, uncontrolled new memberships and lack of adequate tee times.

A strongly worded petition protesting the unreasonable increase in green fees was signed by 200 Senior golfers and sent to the Minister of Lands. Parks and Housing.

"We the undersigned Senior players, who have played on and supported the University Endowment Lands Golf Course for many years, strongly protest the unconscionable and unwarranted increase and added assessments put in place by the Lessee of the University Endowment Lands Golf Course. The annual Senior Fee of \$100.00 plus \$6.00 per round is equivalent to \$8.00 per round based on 50 rounds as compared to the Vancouver Parks Board annual Senior Green Fee of \$171.00 for unlimited play Monday to Friday, or \$3.40 per round based on 50 rounds. We urge reconsideration of this increase in Green Fees that will force many Seniors for economic reasons to forego participation in the healthful exercise and fellowship inherent in the sport of golf."

The reply from Mr. Tony Brumet, Minister of Lands, Parks and Housing, was most unsatisfactory and no relief could be anticipated.

At a meeting called by the University Golf and Country Club in October 1985, all West Point Golf Club members received a letter stating.

"If you wish to continue play at the University Golf Course and claim membership in the University Golf and Country Club, application must be made prior to December 31, 1985."

This notification made it abundantly clear that the new management had no place in their plans for the West Point Golf Club.

The Club found itself at a crossroads, with one segment of the Club heading in one direction and the remainder in another. By the time of the Club's Annual Meeting, it was apparent that the West Point Golf Club was the loser at the University Golf Course. The new operators had formed a propietory Club that would replace the West Point Golf Club and West Point would no longer enjoy playing privileges on the University Golf Course.

It was imperative that a decision on the future of the West Point Golf Club must be made without delay. A General Meeting was called on January 28, 1986. The meeting was attended by 70 members, which was below the expectation for this important meeting to decide the future of the Club, but sufficient to determine a correct course of action. President, Don Gilchrist, chaired the meeting. He reported that 1985 had been a very difficult year for the Executive and there was no future for the West Point Golf Club on the University Golf Course.

Many members were perturbed at the bleak future for the Club, the very substantial increase in club dues, doubling of the green fees, the near demise of the senior rate and the withdrawal of the annual Green Fee tickets. On the other hand, a few members were pleased with the prospect of a country Club atmosphere under the new regime. Most of the week-end players felt that they had little choice other than to join the new organization. It was reported that 210 of the Club's 285 membershad made application at the new club. However, the majority of the Mid-Week seniors felt that the West Point Golf Club would survive on another golf course and remained loyal.

Due to the dramatic change in the Club's circumstance and the uncertainty of the future, it was deemed unnecessary to elect a full slate of Officers and Directors for 1986. A resolution was passed to reduce the Executive to an interim committee of four. Neil McIntyre, Roli Parker, Doug Whittle and Barry Field-Dyte were nominated and elected to the caretaker committee.

The 1985 West Point Golf Club Executive stepped down completing the 1932 to 1985 era of the Club on the University Golf Course. For 53 years the Club enjoyed the leadership of many outstanding Presidents, who guided the Executives and Members to an undeniable record of Club development and achievement. To these Past Presidents the Club owes a resounding thank you.

A NEW ERA BEGINS

Neil McIntyre, Chairman of the 1986 Interim Committee, assumed the chair and opened the meeting to a frank discussion on "The future of the West Point Golf Club". Considerable latitude was given to the discussion due to the unique situation and the necessity of obtaining a positive feeling of the membership in regard to the future of the Club. Much of the discussion centered around the disposition of the funds in the Treasury and the potential for retaining a West Point Golf Club membership. The tone of the meeting indicated that the existence of the Club as presently constituted was doubtful and a new direction must be taken.

Motions, "to hold an Annual Golf Tournament" and "to obtain a clubroom in the new clubhouse" were soundly defeated.

A final motion was carried unanimously;

"The treasury funds at this date, less normal expenses, to be divided equally among the present membership and those signifying their intention to continue membership in the West Point Golf Club shall contribute their share in the "new" West Point Golf Club. The final date for signifying one's intention shall be April 30, 1986."

It was pointed out that at the end of 1985 there were 277 members with an estimated treasury fund of \$9200.00, and each share would be approximately \$33.00.

The meeting decided that the Club should continue on the following basis. The Interim Committe to be charged with the responsibility of canvassing the members, to determine their intent to stay or leave, and to finalize the dissolution of the Club treasury. Those who choose to leave to receive a pro-rata share of the funds. Those who choose to remain to leave their pro-rata share with the Club.

The Interim Committee met on February 3, 1986 to implement the resolution passed at the Annual General Meeting. In order to obtain a true feeling of the total membership, a questionaire was circulated by mail to all members. A reply, by March 15, 1986, was requested to the following questions:

"Do you wish to continue membership in the West Point Golf Club and contribute your share of the treasury funds to the Club" ?

"Do you wish to relinquish your membership in the West Point Golf Club and receive your share of the treasury"?

"Do you wish to donate the Club Trophies to the University Golf Club" ?

"Do you wish to donate the Junior Development Fund to the University Golf Club"?

The result of the survey indicated: 53 Members, primarily Senior Mid-Weekers, elected to stay in the Club and left their share of the funds in the treasury. 224 elected to leave and each was mailed a cheque for \$33.00, which was their share of the treasury funds. More than 80% of the returned questionaires were in favor of donating the Club Trophies and the Junior Development Fund to the University Golf Club. It was later discovered that the University Golf Club did not have a Junior Program and this fund was retained by the West Point Golf Club.

The roster of members, who opted to remain in the West Point Golf Club can rightfully be called "Charter Members" of the "new" West Point Golf Club as of April 1986.

A Special General Meeting of the "new" West Point Golf Club was held at the Kerrisdale Community Center on April 25, 1986. Twenty two members attended this meeting that was called to consider the ramifications of the decreased membership, to decide on a Home Course, to amend the By-Laws to conform to the reduced membership, to elect a 1986 Executive, to approve a program of golf and social activities, to approve an operating budget and to set a membership fee structure.

Interim Chairman, Neil McIntyre, pointed out, "We are still the West Point Golf Club although things are much different from what they were. We are a new entity, a Senior Golf Club, preparing to play on a new Home Course. The full cooperation of every member will be required to keep our Club operating efficiently."

The first order of business was the passage of a Special Resolution to amend the By-Laws. This amendment reduced the Executive to 6 members with 3 members required for a quorum at all Executive Meetings. The Executive to be comprised of a President, Captain,

Secretary/Treasurer, and three Directors. A 1986 Executive was nominated and elected to direct the Club in the difficult days ahead.

Neil McIntyre, the first President of the "new" Club, opened the meeting to a discussion by all members on 'The future of the Club'.

It was decided to use the McCleery Golf Course as the Club's Home Course with Away Games to be played at Langara, Fraserview and other courses that will accept small tournaments. It was pointed out that the Interim Committee had met with Alvie Thompson, McCleery Professional, to discuss the position of the Club on the McCleery Golf Course. He was very sympathetic to the Club's position but was unable to grant tee times or any other special concessions due to the overriding Board of Parks and Récreation Policy. Therefore, the Club members would be responsible for securing their own tee times. Friday was designated as Competition Day, when all Club competitions would be played.

An Annual Budget of \$2360.00 was approved and the 1986 Membership Fees were set at \$30.00 payable by May 31, 1986. A program of social events including two Smoker Get-To-Gethers and an Annual Banquet with Golf Competitions of Weekly Par Points and Honey Pot plus three Club Tournaments were approved. An Opening Day Competition and Lunch at the McCleery Golf Course was planned for Friday, May 9, 1986.

Thus began a new Chapter in the history of the West Point Golf Club after playing at the University Golf Course for 53 years.

The move to the McCleery Golf Course was not without its problems. A new home without a Clubroom available to the members, a depleted membership, disorganized foursomes, and the lack of tee times created temporary difficulties. Therefore, 1986 was of necessity a year of rebuilding and consolidating an active membership, familiarizing the members with their new home, and creating a friendly rapport with the Pro-Shop and Clubhouse staffs.

Our new home, the McCleery Golf Course occupies the site of the former McCleery Farm, which was established in 1862 by the McCleery brothers. The property was sold to the Vancouver Board of Parks and Recreation by Mrs. Harry Logan (nee Theodora McCleery) with the understanding that it would become a recreational area in perpetuity.

The Course was designed by Golf architect, A. V. Macon, who was a good golfer in his own right. His design theory was in shaping the greens to force a player to play finesse shots depending on the placement of the pins.

The Course opened for play on July 3, 1959 with Roy Heisler as Course Professional. A memorial to the McCleery name, which was built with stones from the old homestead, stands adjacent to the Clubhouse.




Club representatives Neil McIntyre, Roli Parker and Jesse Cove presented a brief to the Board of Parks and Recreation regarding the position of the Club at the McCleery Golf Course and requested that the Club be granted tee times one day a week for regular Club competitions. Although very well received, the Board indicated that special tee times or other concessions could not be granted. The Club was registered with the British Columbia Golf Association as a non-voting Club due to the Association policy that only one golf club on a golf course may have voting privileges. British Columbia Golf Association memberships were obtained for all members.

Despite these temporary roadblocks, the Club progressed exceedingly well. Foursomes were established and members soon adapted to securing their own tee times. In a very short time Par Points and Honey Pot were regular weekly competitions.

New trophies began to appear, the McIntyre Trophy for 54 holes stroke play and the Renshaw Trophy for the Club Singles Championship.

Bill Cartwright was the first winner of the McIntyre Trophy. Joe Dwyer became the first Club Singles Champion and winner of the Renshaw Trophy.



The Palcutta Smoker and Tournament was held in September. Fifteen two man teams vied for prizes in the \$570.00 Auction Pool, \$150.00 Player Pool, and \$60.00 Honey Pot. The Harry Dembicki team of Bill Cartwright and Bill Thornton won top prize in the Auction Pool and first prize in the Player Pool. Bill Cartwright claimed first prize in the Honey Pot.

Looking toward 1987, the Club needed to increase its membership to a minimum of 75 from its present membership of 52. To this end, an informational bulletin about the Club and a membership application form were prepared by Roli Parker. This promotional material was directed to the interested non-affiliated, active senior (over 55) players who regularly played at McCleery and wished to join a Club for friendly competition and fellowship.

The Annual Banquet at the University of British Columbia Faculty Club attracted 52 members for an evening of good fellowship, excellent food and a modicum of drink. Captain Frank Maynard officiated at the Competition Awards and the "Old Survivor" Jesse Cove walked off with the top prize in the Reverse Draw.

The jovial evening closed out a very successful first year at the McCleery Golf Course, and served as a true indicator of better things to come.

The second year at the McCleery Golf Course opened with the Annual General Meeting held at the Kerrisdale Community Center on January 30, 1987. Thirty eight members turned out to elect the 1987 Executive and approve plans for the coming year.

The Club was in excellent financial condition with \$1462.00 in the bank. A Budget of \$4886.00 was approved to provide for the Annual Banquet, All Smokers, Opening and Closing Day Lunches, B.C.G.A. Membership Cards, Weekly and Tournament Prizes, and general operating expenses. The Annual Dues were set at \$50.00 and the Initiation Fee \$30.00. It was decided to cap the membership at 75 members for the year.

A great upturn in the fortunes of the West Point Golf Club were evidenced at the turnout of 60 members at the Opening Smoker at the Arbutus Recreation Center on March 20, and the Opening Day Lunch and Competition at the McCleery Golf Course, when 56 members turned

out to fill the 10 booked tee times, courtesy of Alvie Thompson, and two other times booked by members. A match between the Captain's and Vice Captain's teams was narrowly won by the Captain's team. 59 members had lunch in the Clubhouse following play.

In May, the Board of Parks and Recreation abruptly discontinued the Senior Annual and 20 Game Tickets. The West Point Golf Club by letter to the Parks Board and the Vancouver City Council, took the position that they were opposed to the discontinuance of the Annual and 20 Game Tickets, but were not opposed to any reasonable increase.

The letter in part read:- ". . . . Golf Courses should be self supporting, but it has not been indicated that you are losing money from the Golf operations, and this is the yardstick normally used to substantiate such huge increase as that proposed at this time Impose a reasonable increase if such is necessary, but do the tax payer the courtesy of showing why the increase is necessary Discontinuing the Annual Senior Pass, which has been a part of the schedule of fees for many years, will deny many Seniors the opportunity of healthful exercise and friendly competition due to the extraordinary increase in fees."

Subsequently the Parks Board reconsidered and continued the sale of the Annual Pass with an increase from \$185.00 to \$275.00, which was an outrageous increase of nearly 50%. The 20 game ticket was dropped.

Despite the problem of the green fees, membership in the Club continued to increase. By June 30, the maximum of 75 members was reached and further applications were on hand. The category of Associate Member was reinstated to alleviate the burgeoning membership problem. The Executive passed a resolution:

"Associate membership may be granted by the Board of Directors, to any member with at least 2 years playing experience with the Club who by reason of disability can no longer play but wishes to participate in the Club Social Activities."

An annual Associate Membership Fee of \$45.00 was established.

Weekly Par Points competitions continued to be held each week, although the Honey Pot was discontinued due to the difficulty of collecting weekly entry fees with the wide difference in tee off times. Away Tournaments continued to gain momentum. Thirty two members toured the Fort Langley Golf Club on June 26. It was an extremely warm day. Everyone was exhausted after navigating the hilly back nine and the hidden water holes, but an enjoyable time was had by all. Doug Symonds, Doug Whittle, Charlie Barker, and Alec McNiven shared in the prizes of 3 dozen golf balls.

Club Tournaments and Trophies continued to increase. The McIntyre Trophy for 54 holes stroke play, the Reube Haack Monthly Medal Shield for the playoff of Monthly Medal Winners, the July Eclectic for low composite gross score, the High and Low Handicap Shields for Singles Match Play, and the Renshaw Trophy for the Club Singles Championship.

Doug Symonds laid claim to the 1987 Singles Championship and the Renshaw Trophy with a win over 1986 Champion, Joe Dwyer.



Another Away Tournament was held at the Meadow Gardens Golf Club on October 5. 25 members attended this event and vied for 2 dozen golf ball prizes.

The popular Palcutta Smoker and Team Auction was held at the Arbutus Recreation Centre, September 15. A maximum player handicap was set at 28, and twenty 2 man teams, composed of a low and high handicap player, were drawn for the Tournament. The Auction for teams produced an Auction Pool of \$625.00, which together with the Player Entry Pool of \$190.00 and the Honey Pot of \$80.00 made a total pool of \$795.00 available for prizes. The Tournament was held on Friday, September 25. Scoring was by the Quota Points system. Jesse Cove's team of Vic Schroeder and Doug LeBlanc won the top prize in the Auction Pool and Player Pool. The Honey Pot first prize was won by Doug LeBlanc.

The Club, a strong supporter of the Junior Development Program while at the University Golf Course, welcomed the opportunity to support the McCleery Golf Club's Junior Program with a donation of \$200.00. Nearly 80 boys and girls, aged 10 to 18 years, were included in this worthwhile program of instruction and competition.

Closing Day, October 23, was the final competition day of the season. 52 members turned out for the Presidents versus Secretaries team event. The first and second ball event was won handily by the President's team. Other competitions included the playoff of all Monthly Medal Winners for the Reube Haack Shield, which was won by Art Oliver in the low handicap section and Bill Thorton in the high handicap section. Don Close and Cliff Gaynor won gift certificates in the Turkey Shoot. Following play 57 members and the Pro-Shop Staff enjoyed lunch in the Clubhouse.

The Annual Banquet and Awards Nite, November 20, climaxed in great style a very successful year of golf and social activities. Sixty six members turned out for a wonderful evening of fellowship at the University of British Columbia Faculty Club under the sponsorship of long time member Doug Whittle. President Jesse Cove was Master of Ceremonies. Tournament Awards and Prizes were presented by Captain Doug LeBlanc. The Reverse Draw, where every member won at least one golf ball, was won by Bob Osborne with a top prize of \$130.00

1987 EXECUTIVE



The Annual General Meeting, to review 1987 activities and to plan for 1988, was held at the Kerrisdale Community Center on January 29, 1988. The Financial Report indicated the Club was in fair financial condition with a bank balance of \$1309.00, although over spending the Budget had required a \$500.00 draw down on the Treasury in 1987.

An 1988 Annual Budget of \$4871.00 was approved. Due to a projected increase in the cost of social events, competition prizes and Club administration, membership fees were increased to balance the Budget. The new fees were, Regular \$60.00, Associate \$45.00, Initiation Fee \$30.00.

A 1988 Executive was nominated and elected.

The lack of participation by some members, when the roster was full, was a definite problem that required action by the Executive. An analysis of member participation in the Club's golfing activities,

indicated that 20 members participated in 4 games or less on Friday Competition Days during the past season. Also, the participation level of all members was very low; averaging a mere 40% in all Club Tournaments and Away Games.

President Roli Parker in commenting on the situation, said,

"The West Point Golf Club is a Club for golfers who enjoy golf at the Club level. Social activities are secondary. We have too many members, for whatever reason, who are not playing with the Club. These non-participating members are denying potential active members the opportunity to join the Club when the Roster is full."

To bring the member's attention to the necessity of maintaining a high level of participation to retain membership, the Executive passed the following resolution.

"To maintain regular membership in the West Point Golf Club, it is necessary for a member to play a minimum of ten 18 hole rounds on regular Friday Competition Days with Club Members each year."

This resolution was amended at the Annual General Meeting, January 27, 1989 by reducing the 10 game requirement to 5.

The Club continued to receive excellent cooperation from the Pro-Shop Staff. The courtesy and consideration received by every member created a friendly rapport for all. Through the cooperation of Alvie Thompson, the Club received ten pre-booked tee times for Opening and Closing Days and the Palcutta Tournament.

The policy, "cooperate with the existing Club" has been the watchword of the West Point Golf Club since the move to the McCleery Golf Course. The letter of acknowledgement and appreciation from the McCleery Golf Club for the monetary support given to the McCleery Junior Development Program, was a strong indicator of the cooperative spirit existing between the Clubs.

Club competitions expanded. The weekly Honey Pot was reinstated with an entry fee for the season rather than a weekly collection. Par Points continued as a regular weekly competition and the Monthly Medal was played each month. New trophies were added to complete Awards for all Tournaments. The Angel Trophy for the 4 Ball Match Play Event was won by Ed Angel and partner Norm Clark. The Parker Shield for the July Eclectic ended in a tie with John Gilliland and Frank Haylett sharing the low composite score. The West Point Golf Club

Shields for low and high handicap Singles Match Play were won by Ken Child in the low handicap and Ed Angel in the high handicap divisions. In other Trophy Competitions, the McIntyre Trophy for 54 Hole Stroke Play was won by Norm Clark. The Reube Haack Shield for the playoff of Monthly Medal Winners was won by Charlie Barker in the low handicap and Gordon Crosson in the high handicap divisions.

The Renshaw Trophy for the Singles Match Play Championship proved to be an outstanding competition with Norm Kent outlasting Frank Haylett in a very closely fought 36 hole playoff.



Away Tournaments, although not as well attended as in the past, were played at Green Acres Golf Club on May 20, Carnoustie Golf Club on June 24, and Tswawwasen Golf Club on July 25. An average of 30 members participated in each of these events.

At the Palcutta Smoker and Team Auction on September 16, twenty two teams were drawn, one low handicapper and one high handicapper per team, to compete in the Palcutta Quota Points Tournament on September 23. A spirited auction, under the hammer of Neil McIntyre, produced \$660.00 in the Auction Pool. This together with the Player Entry Fee Pool of \$230.00 and the Honey Pot Pool of \$82.00 made a total prize pool of \$972.00. The Roy Symons team of Tyke Kanelles and Harvey Cook captured top prize in the Auction Pool and the Player Pool. Bert Borton gained first place in the Honey Pot Pool.

On Closing Day, October 28, 51 members turned out for the President's versus Secretary's Team Match, which was won handily by the President's team. 4 KP's, a Turkey Shoot and a final Honey Pot were also contested. Following the competitions, 57 members enjoyed lunch in the Clubhouse.

Awards Nite held at the University of British Columbia Faculty Club on November 25. Sixty four members enjoyed an excellent buffet dinner and an evening filled with fun and fellowship. President Roli Parker was the Master of Ceremonies and Captain Doug LeBlanc presented the Awards to the top golfers of the year. The cost of the 1988 Annual Banquet was roughly \$1800.00, and further increases would make the cost prohibitive. Therefore, even though the membership was very well satisfied with the arrangements at the Faculty Club, the Executive decided to look for a more central and less costly venue for next year.



A disappointing turnout of 33 members attended the Annual General Meeting at the Kerrisdale Canadian Legion Hall, January 27, 1989, to review the past year and prepare for the 1989 season. A new Executive was nominated and elected.

A report on the financial condition of the Club showed a bank balance of \$1817.00. The proposed budget of \$5570.00, which was considerably above previous budgets, reflected an anticipated increase in the cost of all social events, competition prizes, and general Club administration. It was decided to make no change in the Regular dues of \$60.00 or the Associate dues of \$45.00, but the Initiation Fee was increased to \$50.00 to partially offset the additional cost as new members joined.

An Opening Smoker was held, March 10, at the Arbutus Recreation Centre. 45 enthusiastic members turned out to renew friendships, meet new members and prepare for another golfing season. Alvie Thompson was our guest and speaker. He spoke interestingly about "Getting started in the Spring". Drawing on his many years as an outstanding golfer and professional, he advised,


"Good preparation in the early spring will avoid many physical and playing problems later in the season. Use ample warm up, mimic the swing of a good player, play conservatively, don't overswing or use hard to play clubs, take lessons on the mechanics of the swing."



There's a Winner Somewhere The Executive published special Playing Rules, to make sure that all members were playing the same game.

"Through the green, except bunkers and water hazards, a ball may be lifted, cleaned and placed no more than 6 inches from the original lie without penalty. It may not be moved if within 36 inches of a tree or out of bounds without a one stroke penalty."

"If a member plays at two or more courses and has handicaps registered at these courses, the lowest handicap registered shall be used when playing at the McCleery Golf Course."

"The latest published handicap for each player will apply in all competitions."

"Differential posting from rated Clubs outside Canada is mandatory not permissive."

A no host Garden Party was held at Reid Mitchell's home on August 18, following golf. A sandwich and beer was enjoyed by the members, while they relayed stories about their superb play.

The Club took advantage of the Canadian "Score Magazine" sales promotion to receive 50 copies of the magazine four times a year for a total cost of \$50.00 for the 200 copies. The B.C. Golf House and Museum was supported with a \$75.00 donation. The Junior Development Fund of \$336.06 was transferred from the Royal Bank to the Club General Account at the Teacher's Credit Union, Dunbar Branch.

In November the Board of Parks and Recreation proposed to delete the Senior Annual Ticket from the Schedule of Green Fees. A strongly worded petition, protesting the proposal, was signed by more than 200 Seniors on the McCleery Golf Course and sent to the Board of Parks and Recreation and the Vancouver City Council.

"We the undersigned Senior golfers, who regularly play at the Vancouver Municipal Golf Courses, strongly protest the Board of Parks and Recreation proposal to delete the Annual Senior Golf Ticket from the schedule of green fees. This disregard and lack of consideration for Senior golfers will make it financially impossible for many Seniors to participate regularly in the healthful exercise and fellowship of the sport that they have supported for many years. We urge reinstatement of the Annual Senior Ticket with an increase of cost commensurate with the proposed increase in the daily rate."

The Board of Parks and Recreation subsequently reconsidered their proposal and retained the Senior Ticket for 1990 at \$250.00 for fifty 18 hole games, or one hundred 9 hole games. All games to be played Monday to Friday only with play restricted on holidays and weekends.

The Annual Banquet and Awards Nite at the Bella Casa Restaurant was an enjoyable affair for the 61 members who turned out at the new venue. The table settings, and general decor were first class. The bar facilities were well attended. The buffet dinner and table service was excellent. Not a single complaint was registered. This transfer of the Annual Banquet to the Bella Casa resulted in a minimum savings of \$600.00 for the Club. President Doug LeBlanc was the Master of Ceremonies. Captain Dave Fairweather presented Trophies and Awards to seven Tournament Winners and Runnersup. The Reverse Draw closed out a great evening. The lucky winners were Norm Clark, Don Close, Dave Fairweather, Charlie Mackay and Jack Pomfret at \$5.00 each; Colin Oliphant \$10.00; Marcel Guiguet \$20.00; Fred Walsh \$25.00 Bella Casa Gift Certificate; George Paquette \$64.00 top prize.



An Annual General Meeting to begin the 59th year of the West Point Golf Club was held at the Kerrisdale Legion Hall on January 26, 1990. Forty three members turned out to review the Club's activities for the past year and approve plans for the 1990 season.

The 1990 Executive was elected by acclamation.

The Financial Statement showed a bank balance of \$1710.80, indicated that the Club was in sound financial position. An increased operating budget of \$5840.00 for the 1990 season was approved.

Membership fees were adjusted to balance the proposed budget. Regular fees were increased to \$70.00 The Associate and Initiation Fees remained at \$45.00 and \$50.00 respectively.

President Ed Angel, commenting on the increased membership fees, said,

"The Club continues to provide many special amenities at no other cost than the membership fee. Entries and prizes in all Competitions, membership in the B.C.G.A., a handicap service, all social activities including the Annual Banquet, a Club bulletin, roster, fixture card, and countless hours of fellowship and friendly competition. It is a true bargain."

A plan was introduced to involve more members in the operation and activities of the Club as a means to increase the level of participation and communication among all members. Two or more volunteer members were appointed to each standing committee, to assist the Chairmen to carry out their respective responsibilities. The work of the Secretary/Treasurer was divided into three separate committees; Secretary, Treasurer, and Divot Dust Editor. Gordie Munro was appointed Editor of the Divot Dust, and George Spilos was named the Treasurer.

A change was made in the requirement to retain competition eligibility.

"To maintain competition eligibility, it will be necessary for a member to play a minimum of five 18 hole rounds with Club members within 12 months of the date of the competition. The rounds must be played on regular Friday Play Days on the McCleery Golf Course or at games played on golf courses of scheduled Away Tournaments. There will be no participation requirement to retain membership."

A pro-rata membership fee was introduced for players, who wished to join the Club after July 1. The resolution read,

"Regular playing members, who join the Club after July 1 in any year, shall receive a 25% reduction in Annual Membership Fees for that year. Associate Members and Initiation Fees shall receive no reduction."

Arrangements were made to hold all regular Monthly Executive Meetings at Brock House. This new venue provided a private meeting room at no charge, and refreshments were available at a very nominal cost. Other inovations were made to tie the Club more closely to the McCleery Golf Course. Permission was obtained to use the McCleery Clubhouse for the Annual General Meeting and to use the Clubhouse area adjacent to the McCleery Clubroom for members to play bridge or cribbage. The putting green near the Clubhouse was obtained for a Putting Jamboree followed by lunch in the Clubhouse.

Fifty three members turned out for the Season Opening Get-To-Gether at the Arbutus Recreation Centre on March 14. Don Gardner, Executive Director of the British Columbia Golf Association was the guest speaker. He reviewed the golf rules applicable to the problem areas on the McCleery Golf Course and led an interesting discussion on the interpretation of the rules in general.





He indicated that a Toronto firm had been given a contract to develop a program for reconditioning and upgrading the three city golf courses. The first step, a survey by an Agronomist, has been completed. His findings indicated that the poor drainage on the McCleery course must be corrected before upgrading of any greens or fairways or the implementation of an automatic water system can be undertaken.

Alvie said, "The McCleery Golf Course will be improved, but at best it will be a 3 to 5 year undertaking. To obtain player input on desirable changes, a questionaire will be distributed by the Parks Board and made available to all players for their respective ideas. Any further progress information will be forthcoming from the Parks Board and the Pro-Shop should not be besieged with questions that have no answers."

In November, the Board of Parks and Recreation again indicated their desire to eliminate the Senior Annual Ticket. To provide a concerted voice in opposition to this latest attempt to eliminate the Senior Ticket, a petition signed by more than 200 senior golfers was sent to the Parks Board and the Vancouver City Council.

"We the undersigned Senior Golfers strongly protest the proposed unconscionable increase in the Senior 50 Game Green Fee Ticket for the Municipal Golf Courses. The increase of 16.8% on the Senior 50 Game Ticket in retlation to the 4.5% increase on the Regular Daily Rate is flagrant discrimination. This disregard and lack of consideration for the Senior golfers, who play for healthful exercise and fellowship, will force the majority of them from the sport that they enjoy and require to maintain their physical well being. Thus the mandate of the Board of Parks and Recreation to provide recreational facilities on a fair and equitable basis for all citizens will be tarnished and open to public rebuke. We urge reconsideration of this outrageous policy."

The Parks Board did not reconsider its discriminatory increase in the Senior Annual Green Fee Ticket, but continued with the outrageous increase that was designed to increase the cost of the Senior Annual ticket to the point where it would not be economic to purchase. The Annual Senior Green Fee Ticket for 1991 was increased to \$312.50.

A new Bag Tag was designed and manufactured for distribution to the members at \$1.00 each. The tag was $3\frac{1}{2}$ inches in diameter with a decorated edge and the West Point logo on the front. The back had a slot for the member's name and the Post Office address of the Club.



An Annual General Meeting was held on January 25, 1991 at the McCleery Clubhouse.

A Special Resolution to amend the By-Laws was presented and approved. The amendments increased the number of Officers and Directors in the Executive to seven. They were to be a President, Secretary, Treasurer, Captain, Vice Captain, Membership Chairman, House and Social Chairman along with an ex-officio member, the immediate Past President. The Secretary to exercise the duties of the President in the President's absence. Four members would be sufficient for a quorum at Executive Meetings.

The Amendments with Revisions and Deletions to the By-Laws that were passed by Resolution at General Meetings of the Society on January 27, 1978, April 25, 1986 and January 25, 1991 were incorporated and printed in a updated Constitution and By-Laws, March 1, 1991. A copy is attached, herewith.

NAME

The name of the Society is the "WEST POINT GOLF CLUB".

OBJECTS

2. The objects of the Society are the encouragement of good fellowship among its members and the promotion of Golf, and other sports and games, and such related recreational activities as the Board of Directors may from time to time deem suitable but not the operation of a social Club.

LOCALITY

The operations of the Society are to be chiefly carried on in the City of Vancouver, in the Province of British Columbia.

BY-LAWS

I.

II.

ADMISSION TO MEMBERSHIP

1. Nomination of Members

Nomination of every candidate for admission to membership shall be submitted in writing on a form provided by the Society, to the Secretary, signed by the candidate and by two members as proposer and seconder, and be ballotted for by the Board of Directors.

2. Honorary Members

Honorary membership may be conferred on any person for such a period as may be prescribed by the Board of Directors present at any regular or special meeting of the Board of Directors, and such honorary members may enjoy all the rights and privileges of a member, save holding office or voting, without payment of fees.

3. Associate Members

Associate membership may be granted, by the Board of Directors, any member who elects to participate in the activities of the Society, save golf competitions and matches.

OBLIGATIONS OF MEMBERS

1. Condition of Membership

All members are admitted only upon the conditions of submission to the by-laws and rules of the Society, both as to restrictions enjoined and penalties imposed.

2. Withdrawal of Members

Any member not intending to continue as such, shall notify the Secretary before the Annual General Meeting of his intention to withdraw. This shall not prevent a member from re-joining at any time providing he leaves under these articles and a vacancy is at hand.

3. Entrance Fee

The fees for each year to be set at the Annual General Meeting; this shall include membership in the B. C. G. A. and the R. C. G. A.

III.

EXPULSION OF MEMBERS

1. Misconduct

Any member, in the opinion of the majority of the Board of Directors, wilfully infringing the by-laws or rules of the Society, or being guilty of conduct in or out of the Society injurious to the character, interest or good order of the Society may be recommended by the Board of Directors to resign.

2. Delinquency

The Annual dues are payable on the first day of January each year, and any member failing to pay before the first day of February shall be held in arrears. Intimation thereof shall be sent to him and until his subscription is paid, he shall not be entitled to compete for any Society prize or otherwise to exercise any of the privileges of membership and if still unpaid on the first day of March, shall cease to be a member of the Society but he shall still be liable for his subscription.

It shall be in the option of the Board of Directors to reinstate him on good cause being shown and on payment of arrears.

No prize will be distributed to any member until such time as his dues are paid.

3. Participation

Members shall be obligated to take an active part in all activities of the Society, and, unless for reasonable cause being unable to do so, may be requested to submit duly attested score cards for a minimum number of required competitions per year to maintain active membership, as prescribed from time to time by the Board of Directors. Failure to comply may be considered, by the Board of Directors, as good and sufficient cause for expulsion from the Society.

4. Summarily by the Directors

Should a member be suspended from membership in the Society for non-payment of dues, or for not conforming to the rules and regulations of the Society, or for any other good and valid reason, the Board of Directors shall call a special meeting of the Board and if two-thirds of the Directors present vote that the name of the deliquent member shall be removed from the roll, the said member's resignation shall take effect eimmediately.

5. Appeal

A member dprived of membership may appeal from such decision to the next General Meeting, if he give notice of such appeal in writing to the Secretary.

IV.

MEETINGS

1. Annual Meeting

The Annual General Meeting of the Society shall be held at the Club House, or at such place in the City of Vanouver as may be selected by the Board of Directors, not later than the 31st day of January of each year.

All meetings of members shall be called by the President or Secretary.

.....cont.

No public notice of the Annual or any meeting of the members shall be required, but notice of the time and place of any such meeting shall be mailed post paid, but not registered, to each member at his last known place of abode or address at least two weeks before the holding of the meeting.

The accidental omission to give notice to any member shall not invalidate any resolution passed at any meeting. The quorum for the transaction of business at meetings of members shall consist of not less than eight (8) members present in person at such meetings.

Vote by proxy shall not be allowed at the Annual or any other meeting of members. Each member shall be entitled to one vote.

The financial statement shall be read and discussed at the Annual Meeting each year.

The order of business at each Annual Meeting of members shall be as follows:

- (a) Roll Call of Officers and proof of Quorum;
- (b) Reading Minutes of preceding members' meeting;
- (c) Report of Committees;
- (d) Unfinished business;
- (e) Election of Directors and all Officers in connection with the Society;
- (f) New business:
- (g) Adjourn

٧.

2. Special Meetings

Special meetings of the members may be called at any time by the Board of Directors on five days' notice by mailing a copy of said notice to each member.

BOARD OF DIRECTORS

1. Number and Authority

The number of Directors shall be seven (7), and they shall manage the affairs of the Society. The immediate Past President shall be an ex-officio member.

2. Nominations and Nominating Committee

All nominations for the Board of Directors shall be made at the Annual General Meeting. Nominations may be made by a Nominating Committee and from the floor. All nominees shall be present, or in case of unavoidable absence, the nominator must have prior consent of his nominee to act if elected.

A three member Nominating Committee shall be appointed by the President for the purpose of selecting a slate of Officers and Directors for the ensuing year. The Chairman of this Committee to be a member who has served as President during the preceding five years, but not presently an Officer of the Society. One member shall be from the current Board of Directors and one from the membership in general. This Committee to be formed not later than the 31st day of March each year, and to meet during the year to give serious thought and consideration as to the best qualified people available for Officers and Directors of the Society. This Committee will present their selections to the Board of Directors on or before the 31st day of December of each year and to the members of the Society at the Annual General Meeting for their consideration.

3. Election

At the Annual General Meeting, seven (7) Directors shall be elected for a term of one year, and any Director shall be eligible for re-election.

4. Vacancies

The Board of Directors shall have the power to fill any vacancies occurring in their numbers in the course of the year.

VI.

OFFICERS AND THEIR DUTIES

1. Officers

The Officers of the Society shall be; President, Secretary, Treasurer, Captain, Vice Captain, and two other Directors.

2. Duties of President

It shall be the duty of the President to preside at all meetings of the Board of Directors and of the members, and with the Secretary or Treasurer to sign cheques, to appoint all Committees not otherwise provided for, and he shall be ex-officio a member of all Committees.

3. Duties of Secretary

The duties of the Secretary shall be:

To exercise the duties of the President in the President's absence. To keep a record of all matters transacted at the meetings of the Society or Board of Directors or any Committee thereof.

To notify candidates for admission of their election.

To execute such writings and acts, matters and things as he may be

To execute such writings and acts, matters and things as he may be instructed and authorized by the Board of Directors to do.

4. Duties of Treasurer

It shall be the duty of the Treasurer:

To develop, administer and control the Annual Budget of the Society.

To prepare a financial statement for presentation at the Annual Meeting of the Society.

To collect all fees, dues, subscriptions and charges and deposit same to the credit of the Society with its Bankers.

To keep a regular account of all receipts and disbursements subject to examination by the Board of Directors at its regular meetings and by the Auditor.

5. Duties of Captain

It shall be the duty of the Captain:

To arrange and maintain an annual schedule of Society golf events. To administer all competition arrangements including playing times rules and conditions for play, scoring, handicapping, local rules and awarding of prizes.

To preside at all Society golf matches, tournaments and competitions. The Captain shall be Chairman of the Match and Handicap Committee.

6. Duties of Vice-Captain

The Vice-Captain shall assist the Captain in all matters pertaining to the organization and operation of all matches, competitions and tournaments of the Society.

In the absence of the Captain, the Vice-Captain shall exercise the duties of the Captain.

The Vice-Captain shall be a member of the Match and Handicap Committee.

MEETINGS OF DIRECTORS

1. Time, Place and Voting

Meetings of the Board of Directors may be called at any time by the President, or in absence by the Secretary, or shall be so called when a request in writing is made by the majority of the Board of Directors so to do. Notice of all such meetings shall be given at least two days before the day of the meeting, to each Director. If, in the opinion of the President or in his absence the Secretary, urgent business is required to be disposed of, one day's notice shall be sufficient.

Meetings of the Board of Directors may be held at any time, without notice, if all the members be present and consent thereto, or if those absent signify their consent to such a meeting.

All meetings of the Board of Directors shall be held in the Club House or at such places in the City of Vancouver as the President, or in his absence, the Secretary may select.

All questions, save those required by thes By-Laws to have a special majority, shall be decided by a majority vote; in case of a tie the President, or in his absence, the Secretary, shall have a second or casting vote. $\frac{1}{2}$

2. Quorum

Four (4) members of the Board of Directors, present, shall constitute a quorum.

3. Order of Business

The order of business at all meetings of the Board of Directors shall be as follows:

- (a) Reading the minutes of the last meeting and confirming same;
- (b) Receiving the report of the Secretary;
- (c) Receiving the report of the Treasurer;
- (d) Receiving the reports of the Standing Committees;
- (e) Receiving the reports of Special Committees;
- (f) Special Orders;
- (g) Unfinished business;
- (h) New business;
- (i) Good and Welfare;
- (j) Adjourn.

This order of business may be altered at any meeting by a majority vote of those present.

4. Powers

The Board of Directors shall have power to appoint such Committees as it may deem desirable and shall prescribe their duties; to fill vacancies that may occur in any office; to enforce penalties for the violation of these By-Laws or any rules made by the Board of Directors or any of its Committees; to call Special Meetings of the Society; to make and execute contracts in the name of the Society or authorize its Officers or Committees so to do; to appoint or dismiss at pleasure any Officer or Director of the Society.

It shall present at each Annual Meeting of the Society a report showing the financial condition, resources and obligations of the Society and make such recommendations as to its welfare as it may deem proper.

.....cont.

It shall have power to make rules and regulations and to do all other things which it may deem necessary for the proper operation, government and management of the Society.

VIII.

COMMITTEES

1. Appointment and Authority

The Board of Directors shall appoint Standing Committees as follows: Match and Handicap Committee, House and Social Committee, Membership Committee, Junior Development Committee.

Each Committee shall be composed of a minimum of three members of which at least one member shall be a Director.

The Board of Directors may appoint Special Committees, membership of which may include members who are not Directors.

The Committees shall in all respects be subject to the Directors, who shall decide all questions as to their duties, powers and jurisdiction, and may at any time control their actions. Subject, however, to this the decisions of each Committee shall be binding upon the members of the Society.

No Committee shall incur any expense without authority of the Board of Directors. All bills shall be approved by the Chairman of the Committee that authorized the expendicture before presentation to the Treasurer.

2. Match and Handicap Committee

The Captain shall be Chairman of the Match and Handicap Committee.

The Committee shall develop and manage an Annual Schedule of Society golf matches, competitions and tournaments.

It shall supervise and control all Society golf matches, competitions and tournaments including setting up rules and conditions for play, making draws, checking score cards and handicaps, and the offering and awarding of prizes.

It shall make, amend and enforce local rules and interpret and apply the name as well as the Rules of Golf.

It shall periodically check score cards and differentials to insure that all differentials are being turned in nad that errors in computations are not being made.

It shall maintain and control a handicap system and insure that handicaps are determined and altered on a regular basis.

It shall maintain a complete record of all Society matches, competitions, and tournaments including the winners, scores and prizes awarded.

3. House and Social Committee

A Director shall be appointed Chairman of the House and Social Committee. The Committee shall be responsible for the planning, organization, arrangement and control of all Society functions.

It shall maintain a complete record of all monies received and disbursed on behalf of the Committee at each function, and make a full accounting to the Board of Directors following each event.

4. Membership Committee

A Director shall be appointed Chairman of the Membership Committee. The Committee shall receive all applications for membership in the Society and determine the eligibility of the applicants according to the rules pertaining to the qualifications for membership, and shall submit their recommendations to the Board of Directors for action.

All applications for membership shall be processed in the order of receipt.

The Committee shall maintain a complete roll of members of the Society including, names, addresses, postal codes, phones, and classification of membership.

5. Junior Development Committee

The Chairman of the Committee shall be a Director of the Society. The Committee shall be responsible for insuring the continuity of an adequate Junior Development Program. It shall establish and maintain a program of education in regard to golf etiquette, golf rules and regulations, and golf course care and maintenance. It shall be responsible for the behavior of all Junior members using the Golf Course and Club House.

IX.

AUDIT AND LEGAL

1. Auditor

An Auditor shall be appointed by resolution of the members at the Annual General Meeting and he shall hold office until the next Annual General Meeting or until his successor is appointed, unless previously removed by resolution of the members at a Special General Meeting. It shall be his duty to make an Audit on the closing of the Books at the end of the Fiscal year.

2. Solicitor

A Solicitor may be employed by the Board of Directors, who may or may not be a Director, and who shall be entitled to be paid for services rendered.

x.

CUSTODY AND USE OF THE SEAL

The Seal shall be in the custody of the Secretary of the Society and shall be used only as directed by resolution of the Board of Directors.

XI.

FISCAL YEAR.

The fiscal year of the Society shall begin on the first day of January and end on the last day of December in each year.

XII.

ALTERATION OF BY-LAWS

The By-Laws of the Society may be amended at any general, special or annual meeting of the Society by extraordinary resolution adopted by two-thirds majority vote of the members of the Society present at any special or annual meeting.

Notice to amend any By-Law or to introduce a new one shall be given in writing at a meeting of the Society previous to the meeting or circulated to the members two weeks in advance of the meeting at which it is intended to be considered.

XIII.

INTERPRETATION OF BY-LAWS

On all questions of interpretation of these By-Laws, the decision of the Board of Directors shall be final unless overruled by the members at an Annual or Special General Meeting.

XIV.

BORROWING POWER

The Board of Directors may borrow, or raise or secure the repayment of money only in such manner and upon such terms as authorized to do so by an extraordinary resolution of the Society adopted by two-thirds majority vote of the members of the Society present at a special meeting called for that purpose and for which two weeks notice in writing of the resolution to be presented shall be given to the members.

XV.

RECORDS

1. Custody and Preparation

The preparation and custody of minutes of proceedings of meetings of the Society and of the Board of Directors and other books and records of the Society shall be the responsibility of the Secretary.

Inspection

Every member shall be entitled to inspect the records of the Society upon payment of a fee of \$1.00 and to receive a copy of the Constitution and By-Laws on payment of a fee of \$1.50.
